The Association of Graduates recently learned of the death of our classmate John J. "Jack" **Dougherty**, CS-07. Jack passed away on 24 Apr 2014 in Ringgold, GA. A funeral service was held on 27 Apr at the First Decatur United Methodist Church in Decatur, GA. Jack was predeceased by his wife, Jeanette.

Upon graduation in 1963 Jack went into the Marine Corps and served in SEA as a fighter pilot flying the A-4M Skyhawk. Jack was a career pilot for Delta Airlines. He also earned a Juris Doctor (JD) degree from the Woodrow Wilson Law College.

In case you did not receive this information from **Diff** I am repeating it here. "For some 50 years our class has been represented at memorial services for fallen classmates by a flower arrangement and a note to the surviving family. Often the AOG receives notification too late to send flowers; then, we are not represented at these services. Therefore, we are changing to the following. By this announcement and others that will appear, you should know the Class of 1963 will make a gift to the Air Force Academy in your name when you pass. The AOG will send a letter to your family notifying them of the gift, and I will continue to send a personal note on behalf of the class. These gifts will accumulate. When we gather for the next reunion, the total gift will be presented to the Academy."

Diff also added; "Thank you" to donors in our recent request to bolster our class funds. As of mid-July 2014, we have approximately \$4,000 in our Agency Fund and \$1,500 in our Gift Fund. All debts from the 50<sup>th</sup> have been paid."

Gil **Merkle** provided a tally of the Class Histories web site effort: In addition to written biographies and photos, we collected 417 short video clips from classmates. The videos totaled 2,905 minutes (48.4 hrs) of recorded personal stories that were collected by classmates and placed onto the class histories website at <u>http://www.usafaclasshistories.org</u>.
